 2. Novice contestants are eligible if they have never won an overall title in any NPC sanctioned event.
 3. Men's Masters and Master's Figure must meet the age requirements for the class they are entering.
 4. Teenage contestants may not have reached their 20th birthday by the day of the show.
 5. All Open Figure competitors must be 18 years of age or older the day of the contest.
 6. Bodybuilding Contestants may crossover to the men's open division only. Figure contestants may crossover to the figure open division only (No crossovers from figure to bodybuilding).
 7. Each crossover contestant must pay a separate entry fee for each division entered (\$60 per division or \$120 total).
 8. The Men's Open, Women's Open and Open Figure classes are NPC national qualifying events.
